What is CONtact innovator mentorship program

Construction is evolving into a tech-savvy industry, and innovation & attracting a younger workforce are top priorities of Canadian Construction Association's (CCA) 5-year strategic plan. In support of this, Canadian Construction Innovations (CCI), the not-for-profit organization associated with CCA, is driving the technology & innovation strategy forward with the launch of the CONtact innovator mentorship program.

This unique service will provide a platform for aspiring entrepreneurs and innovators to connect with industry leaders and help hone their solutions for industry adoption. The program will also provide a new opportunity to attract young, tech-savvy workers to the industry. CONtact is presented by CCI in partnership with the CCA and with the support from National Research Council of Canada Industrial Research Assistance Program (NRC IRAP).

Become a CONtact mentee

How it works

CCI will match industry volunteers with pre-selected, high-potential entrepreneurs and innovators to participate in the mentorship program.

The mentorship meeting will take the form of a maximum three-hour feedback session, whether in person or virtual. This meeting may include other mentors.

CCI will coordinate the matching and the three-hour meeting.

The session is not a "pitch" to sell to the mentor. It is designed to provide feedback on the entrepreneur's product or service solution on value, price, features, distribution, feasibility or any other element that will improve the likelihood of adoption.

CONtact may cover eligible travel costs for both mentors and mentees for a single face-to-face meeting.

Any subsequent meetings or feedback will be initiated as desired by the volunteer mentor.

The CONtact innovator mentorship program is a valuable opportunity for mentees to learn and tap into the knowledge of established industry professionals not only to refine their product or idea but also to build lasting relationships within the industry.

- Learn from experienced mentors to fine tune their product offering;
- Establish new relationships and networking with industry professionals;
- Receive practical feedback from an industry professional or professionals; and
- Acquire knowledge, skills, tactics, and competencies.

If travel is required, the mentee will be paid for travel costs for a single face-to face meeting with the mentor.

Requirements

✓ You are an entrepreneur or innovator with a product or service with an innovative solution for the Canadian construction industry and based in Canada;

You are an incorporated, profit-oriented small- or medium-sized business in Canada;

You have 500 or fewer full-time equivalent employees;

- You plan to pursue growth and profit by developing and commercializing innovative, technology-driven new or improved products, services or processes in Canada;
- ✓ If it is a technology-based product or service, the innovation could be at any stage of the <u>technological readiness scale</u> seeking to improve the offering.
